Professional Offices Sought for Commercial Corner

At his request, the Mayor and Council met on June 7 with Mr. Steve Beck, representing the owner of the commercial building, to talk about possible business uses in the Town's commercial zone. With the closing of the meat market, the catering business is no longer a

permitted use. Our Town ordinances currently provide for the following uses: Post Office; professional, business, or government offices; retail sale of antiques; barber and beauty shops; dry cleaning and laundry pick up stations; shoe repair shops; tailoring.

The principal intent is that these or alternative businesses in the commercial zone should have traffic, noise and impact that is compatible with the adjacent residential zone. Draft Tree Ordinance a Topic at Town Meeting

The Town's Planning Commission has been wrestling with ways to insure preservation of the forest canopy throughout the Town. To encourage thoughtful consideration of alternatives before trees of substantial size are cut down or cut back on private property, an ordinance creating a permit process has been drafted. After a lengthy discussion at Town Meeting, it was decided that residents would have an opportunity to comment on the draft ordinance at the September Planning Commission meeting, allowing time for all concerned to study the draft language. Details in July.

Energy Use Information Meeting

On June 16 in McCathran Hall, informative presentations were given by Joan Stern, State delegate in District 39; Ron Talbert, HVAC heating and air conditioning contractor; Ken Fisher, president, Gaithersburg-Washington Grove Volunteer Fire Department; and Tara Huston and Andrew Hickey, sales representatives of Washington Gas. A broad range of issues were discussed including the recent deregulation of some public utilities, details of converting home appliances to use natural gas, general home safety with particular focus on flue/chimney maintenance and aging oil tanks, and the requirements of Washington Gas for installation of residential gas distribution lines within the Grove. The Washington Gas representatives indicated that it may be possible for select areas within the Grove to be supplied with gas service, with much of the expense for installation being assumed by gas subscribers. In the near future,

Washington Gas and the Town of Washington Grove will be sending out a joint survey to assess the level of interest of all Grove homeowners and to determine costs. This survey will form the basis of any negotiation for gas services between the Town and Washington Gas. Residents are encouraged to return the survey and to speak with other residents about gas use.

Board of Zoning Appeals Grants Special Exception

Following a public hearing on May 26, the Town's Board of Zoning Appeals unanimously voted to grant a special exception to permit the retail sale of incidental items at a beauty shop to be operated at 113 Hickory Road. The Board determined that granting the special exception would not significantly burden the Town with increased noise, litter, or pedestrian or vehicular traffic.

NOTICE OF PUBLIC HEARING APPLICATION FOR VARIANCE

Date: Wednesday, August 11, 1999 Place: M^cCathran Hall Time: 7:30 p.m. Pursuant to Article VII, Sections 12.32 and 11.31 of the Washington Grove Code of Ordinances, a public hearing will be held to determine if a variance should be granted to allow the construction of a porch on the front of the Poblete residence at 415 Center Street.

The construction of a porch violates the setback requirements of Article VII, Section 9. Schedule of Standards.

The Board may grant a variance if the Board finds on the basis of preponderance of evidence that the seven conditions as presented in Article VII, Section 12.2(a) exist.

The Board will take written and oral testimony from the applicant, residents or other interested parties in advance of, or at the public hearing. The Board will render its decision as soon thereafter as practical.

Building Permits

If you are going to erect a building or structure (including fences), make structural alterations to, or move any existing building or other structure, you must first obtain a building permit from the Washington Grove Planning Commission. The Town zoning ordinance governs setbacks, lot coverage, and height. Applications are available at the Town Office at 301-926-2256. Please allow at least 10 days for review by the Commission. Call John McClelland at 301-963-3328 if you have questions about zoning code requirements. Interior renovations which involve electrical, plumbing, or load-bearing changes generally require a County permit. All applications for County-required building permits must first be signed off by the Town.

Notice of Public Hearing on Proposed Annexation

The Town Council will conduct a hearing on Monday, July 12 at 7:30 p.m. prior to the regular monthly Council meeting, to take public comment regarding Annexation Resolution No. 99-03, proposing annexation of approximately 0.42 acres located at 3 Ridge Road, the same property as described in Liber 6319 at Folio 683 among the Land Records for Montgomery County, Maryland. Resolution No. 99-03 provides that the Town issue a property tax credit to the owners of 3 Ridge Road each year for a period of five (5) years in an amount equal to the total property taxes imposed for 3 Ridge Road by the Town. The proposed annexation would include

Ordinance No. 99-04 classifying the property in the Town's RR-1 Zone (residential, one family, minimum lot size 11,250 square feet).

THE GAME

Grove Stadium, 3 July 1999 at 5 PM Rule 1: No matter what rules are being followed, the game does not continue till the ball is found.

"The Game" will be played at Grove Stadium on 3 July at 5 p.m. Players will come for organization and rules at 4 p.m. Two teams will play, the "Red Grovers" and the "Green Grovers". (Everyone wanted to be a "Grover".) The Game will use a soft baseball-sized ball.

Baseball rules for the Town of Washington Grove from 1873 will apply and be rigidly enforced by the officiating authorities. Reference is the Encyclopedia Britannica, 1873 version (available at the game).

- 1. Players and fans will be genteel and mannerly at all times.
- 2. There will be ten players per side playing seven innings, three outs per side per inning and the side with the most runs wins the game. Any resident 14 or older can participate. (The extra player is the right side shortstop and must be an outstanding individual of great coolness who serves as the general in the field.)
- 3. Players will be required to use period banter (*e.g.*, red hot, what the blazes) and are suggested to have period nicknames (e.g., Squid, Dutch, Pigtail, The Man, Rev, Live Wire, Blue Streak).
- 4. Hats (maroon or forest green) will be provided to players and officiating authorities; wood bats are required (please bring one); gloves are recommended and spikes are not permitted.
- 5. Strikers (batters) will inform the umpire either "high" or "low" when asked "What is your pleasure, sir/madam?" The pitcher will respond with a high pitch (waist to shoulder) or low pitch (waist to one foot above the ground). The striker will have four fair pitches to achieve a hit or five unfair pitches to achieve a walk. The striker attempts any unfair pitch at their own risk. Three consecutive unfair pitches will allow the striker to proceed to first base. "Hand down" results in the striker being out as this is a "bound game".
- 6. In delivering the ball pitchers will not place either foot outside of the 6'x6' pitcher's box, must not raise their hand higher than the hip, must deliver the ball over the plate at the requested height and must not "balk". Pitches not placed as requested are ruled unfair. Three balks in an inning results in the offending side forfeiting the game. Catchers play behind the striker and must be within 50' of them.
- 7. Runners will stay in the marked base line (3' wide) at all times when proceeding around the bases. Runners will not be obstructed.
- 8. Other, more voluminous rules apply.
