ICC Meeting Set

The Mayor and Council have scheduled a meeting to discuss the Inter-County Connector with a State Highway Administration person and a private consultant for Tuesday, January 27th at 7:00 p.m. in McCathran Hall. The public is encouraged to attend. This is your chance to voice your concerns about this controversial project.

Proposed Ordinance Revisions

The Mayor, Council and Planning Commission have proposed changes to the Ordinances of the Town of Washington Grove. Copies of the complete proposed changes will be available in the Town Office on January 23, 2004. A summary of the changes is as follows;

Article I, Sec. 12: clarification of penalties for Ordinance violations. Article III, Sec. 4 & 11: increased parking fine, clarification of weight regulations for vehicle traffic allowing pickup and delivery of goods. Article IV, Sec. 1 & 2: added requirements for removal and demolition of structures and added requirements for building permit applications. Article VII, Sec. 3, 4, 5, 7 & 9: clarification of carport requirements, clarification of limits on obstructions at intersections, a new ordinance addressing open porches, definition of certain terms, clarification of alterations of non-complying buildings, addition of restrictions for parking and/or storing of commercial vehicles, changes to the schedule of standards regarding building height restrictions and floor area ratio.

Casey Field

Residents of Ridge Road recently received the newest revision of the plan for the Oxbridge Development (Casey Property at Mill Creek). M- NCPPC is still expressing concerns about the environment, about road-calming devices and about storm water management. Mayor Compton will send a letter to the Planning Board that will outline the Town's position concerning the density of the development, the impact on Washington Grove, the preservation of the character of the Town and the size of the buffer.

New Plans for the Casey Industrial Land
The Mayor and Council met with the latest contract purchaser of the
property previously proposed for development by KSI (project since
withdrawn). They discussed a development plan that would involve 1) a land
swap with the County to move a County service park (likely DPWT) from
Crabb's Branch Way to the site adjacent to Robert's Oxygen and the Town, 2)

approx. 65 town homes sited along this side of I370, 3) approx. 300 residential units between I370 and Shady Grove Road. This plan requires a zoning change, (I-1 to I-3a), as proposed in the revised Master Plan now before the Planning Board and agreement to the land swap by the County Council and County Executive. Stay tuned.

Building Permits:

If you are going to erect a building or structure (including fences), make structural alterations to, or move any existing building or other structure, you must first obtain a building permit from the Washington Grove Planning Commission. The Town zoning ordinance governs setbacks, lot coverage and height. Applications are available at the Town Office at 301-926-2256. The permit fee is \$10.00, payable to the Town of Washington Grove. Interior renovations, which involve electrical, plumbing, or load-bearing changes, generally require a County permit. A shed requires a County permit as well. The Town must first sign off all applications for County-required building permits. The Historic Preservation Commission will review most permits as well.
