State law requires that an annual audit of the Town's records be conducted by an independent certified public accountant. Council Proposes to Move Elections and Town Meeting to May - Res. No. 2006-05

On November 13, the Town Council introduced a charter amendment proposing to move the date of Town Elections and Town Meeting to the second Saturday in May. Montgomery County now requires that the Town's property tax rate be submitted to them no later than May 31 in order for Town taxes to be included on the County's consolidated property tax bill. The amendment also proposes to move the deadline for nomination to elective office from the second Monday in April to the second Monday in March, and moves the budget adoption process earlier. A summary of the proposed budget will be circulated with the April Bulletin. (Charter Sections to be modified include 5, 30, 31, and 42) Council Proposes to Modify Position of Clerk-Treasurer Permitting Duties to be Performed by One or More Town Employees - Res. No. 2006-06

A second amendment, modifying Sections 38 and 40 of the Town Charter, was introduced by the Town Council on November 13. This amendment proposes to permit the Mayor, with the Council's approval, to assign all or part of the duties of the Clerk-Treasurer to one or more employees of the Town. The purpose of this amendment is to bring the Charter into line with current practice. Administrative duties have increased in scope and detail to a work week commonly in excess of forty hours. The amendment will permit the Mayor and Council flexibility in job assignments. Notice of Public Hearing

Verizon Maryland, Inc. Cable TV Services in Town Ordinance 2006-07 was introduced on November 13 by the Town Council. If adopted at the December Council meeting and allowed to become law, the ordinance permits the Mayor to execute agreements granting Verizon Maryland, Inc. a non-exclusive franchise to operate a cable communication system within the Town. As with Comcast, the Town has participated as a co-franchisor with Montgomery County and other County municipalities in hammering out an agreement with

Verizon favorable to the County and its municipalities. It is anticipated

that introducing competition will serve the best interests of the Town and its residents.

Legacy Open Space (LOS) Update

The Town's legal expenses are over 100% of the year's budget for the condemnation of the LOS. It is likely that the Mayor and Council will convene a Town Meeting to consider approval of additional funds. In the meantime, Attorney William Chen has been asked to attend a PUBLIC INFORMATION SESSION on December 13, 2006 at 7:00 p.m. in McCathran Hall to update the Town Council and residents. Mr. Chen will first take questions from the Mayor and Council and then from residents as time allows. The meeting will last for approximately one hour. So, mark your calendars... Another Challenge...

A Preliminary Plan for development of the Casey 6 parcel (borders I370, RR Tracks, Roberts Oxygen, Town of Washington Grove & Toll Brothers properties) and Casey 7 (borders Shady Grove Rd., RR Tracks, I370 & Crabbs Branch Way) has been submitted to Park & Planning for consideration. This plan shows 4-story office condominiums, 3-story residential condominiums, 4 & 5 story parking garages, and residential town homes. The Mayor testified on Thursday, Nov. 9, 2006 at a Planning Board hearing considering this plan submitted as a Pre-Preliminary last October(!). The Preliminary Plan is similar. If you are going to erect a building or structure (including fences), make structural alterations to, or move any existing building or other structure, you must first obtain a building permit from the Washington Grove Planning Commission. The Town zoning ordinance governs setbacks, lot coverage and height. Applications are available at the Town Office at 301-926-2256. The permit fee is \$10.00, payable to the Town of Washington Grove. Interior renovations, which involve electrical, plumbing, or load-bearing changes, generally require a County permit. A shed requires a County permit as well. The Town must first sign off all applications for County-required building permits. The Historic Preservation Commission will review most permits as well.

Zero Waste! Can we really do it? Well, according to second law thermodynamics, no. However, there are many cheap and painless ways to reduce waste. Each month this section will expound upon the first two elements of the "Reduce, Reuse, Recycle" mantra, with the third also mentioned when appropriate.

This month: Bringing Down Mail Mountain Reduce the number of catalogues you receive. Inside of each

catalogue-usually on the order page-there is a phone number or address with instructions on how to remove your name from their mailing list. Putting your name on a general "Do Not Mail" list is not sufficient, as it will not stop catalogues from any vendor with whom you have ever done business. For more information on how to remove your name from myriad mailing lists and reduce junk mail, go to the following web site: www.privacyrights.org/fs/fs4-junk.htm.

Receive your bills and statements electronically. Nearly all utilities, banks and insurance companies provide this option, because it saves them money. Check your paper statements for instructions on converting to electronic bill receipt and payment, or go to each vendor's web site. Unwanted mail can be included with your Montgomery County curbside paper recycling, so please do not leave it at the post office! If you have concerns about privacy, shred your mail before adding it to the recycling bin. Remember, all of the following types of paper products can be recycled: newspapers and inserts, corrugated cardboard, cereal and other boxes, telephone books, computer and office paper, paperback and hardcover books (although I recommend you donate or "freecycle" these), magazines, catalogs, shredded paper, envelopes and boxes with plastic windows, and all other clean and dry paper.

Leaf pickup will begin November 1st. New and long-time residents alike are reminded that the Town contracts for the removal of leaves in bulk each autumn. US Lawns will make regular but unscheduled pickups of leaves raked or blown into windrows within six feet of any walkway or roadway, excluding Railroad Street, 2nd Ave., 3rd Ave., 4th Ave., 5th Ave., and Boundary Street. This service begins November 1 and ends January 1, 2007, or as soon thereafter as we agree that the work is complete. This is your opportunity to have leaves removed without the additional work and expense of bagging.

Weather frequently affects this process, as rain can restrict movement of large trucks on the avenues. Also, one or two spectacular fall weekends in November or early December usually see most of us raking at the same time. As the contractor will time pickups based on the availability of full truckloads for vacuuming, if you rake when most other people rake the windrows will probably disappear relatively quickly. Please place your windrows with an eye towards traffic visibility and flow, and don't include brush or limbs that foul the vacuum. Happy raking! It's the rite of autumn, particularly in a town graced by so many beautiful deciduous trees.
