Actions at the January Council meeting included: Introduced Ordinance #2007-01 amending sections of the Town code concerning commercial vehicles in residential zones, the criteria for special exceptions, and the definition of an Accessory Building.

The Mayor and Council have tabled work on Ordinance #2006-03 and #2006-04 proposing an optional method of subdivision in the Town. In the meantime, annexation of the Cator property (17050 Railroad Street) will be pursued in an agreement with the property owner. NOTICE OF PUBLIC HEARING

The Washington Grove Town Council will hold a public hearing on Monday, February 12, 2007, 7:30 p.m., in McCathran Hall, 300 Grove Avenue, Washington Grove, Maryland. This hearing is to take public comment regarding Zoning Text Amendment 2007-01 which corrects errors made on ZTA #2005-05 and ZTA #2005-07. This action affects Article VII, Section 7.2 Use Regulations; Section 11.32 Criteria for Special Exceptions; and Section 4.2 Definitions.

Legacy Open Space Condemnation

Preparation continues for a trial to determine the fair market value with depositions being discussed. A motion for a judicial ruling on the Town's authority to condemn the property is planned to clear the way for the trial. At the same time, we are continuing to seek alternatives to condemnation with MNCPPC.

Casey Field Development

Phase I Site Plan Review Process: Still awaiting action on a storm water management plan.

School site reservation/purchase: Following discussions between MCPS and MNCPPC officials, Park and Planning has proposed to purchase the site with their own advanced land acquisition funds. This proposal requires approval of the new County Council, whose level of commitment to the Shady Grove Master Plan is unclear. The Town and residents will likely be called upon to express strong support of the Plan and the school site acquisition in testimony and letters.

Casey 6 and 7; Siting of the ICC Western Maintenance Facility: Strong opposition has been raised to the SHA plan to use Casey 7 by a host of organizations- Park and Planning, the property owners (EYA), the Shady Grove Master Plan Citizen's Advisory Committee, and other local groups. A proposal to use part of Casey 6 adjacent to I370 is deemed preferable, pending review of actual site plans. The submitted preliminary plan for Casey 6 and 7 may be abbreviated to a phase I plan to extend Crabbs Branch Way to access the proposed site.

If you are going to erect a building or structure (including fences), make structural alterations to, or move any existing building or other structure, you must first obtain a building permit from the Washington Grove Planning Commission. The Town zoning ordinance governs setbacks, lot coverage and height. Applications are available at the Town Office at 301-926-2256. The permit fee is \$10.00, payable to the Town of Washington Grove. Interior renovations, which involve electrical, plumbing, or load-bearing changes, generally require a County permit. A shed requires a County permit as well. The Town must first sign off all applications for County-required building permits. The Historic Preservation Commission will review most permits as well.

Paper or plastic? The greenest answer to this age old question is "neither". Bring re-usable bags every time you shop. Now that you have given and received gifts wrapped in re-usable bags, use them. Canvas bags or sturdy paper bags can be used many times. Keep a bag of bags next to your door so that you have them handy when you go shopping. Minimize the extra bags you accumulate during shopping. Items such as apples oranges and bananas don't need to be placed in separate bags; mixed baby lettuce leaves probably do. What's best if you forget to bring your bags? In a head to head comparison, plastic bags win by a narrow margin over paper bags. Surprised? See http://www.bankrate.com/brm/news/cheap/20041215a1.asp for one such comparison. If you do use plastic bags, be sure to collect them and bring them back to the store for recycling; remove all paper receipts from the bags first. Paper bags can be re-used or included with your normal recycling. However, no matter how conscientious you are about recycling the bags, both single-use paper and plastic lose by a mile to the re-usable option.
