authorization to purchase a water wagon for watering the athletic field and new trees.

decision to form a study group to review the current permitting policy for the use of Woodward Park.

approval/enactment of Ordinance 2007-09; Penalties and Enforcement of Town Ordinances. A summary is as follows;

Establish a system and schedule for fines to be imposed for municipal infractions in connection with violations of the Town's Code of Ordinances. Identify those persons charged with prosecuting such enforcement actions. Revise out-dated language regarding penalties for misdemeanor violations. Codify the inherent power of the Town to seek injunctive relief to abate any violations, and recover costs and attorneys' fees for any such action. Revise the 'Severability' language contained within the Code.

Clarify that all previous versions of Article IX are superseded by this Ordinance.

approval/enactment of Ordinance 2007-07; Home Occupations in Principal Residences. This ordinance change will require that the operator of a home occupation in a residential zone must be a resident of the property involved, and that the property involved must be the "principal residence" of that same resident.

introduction of Ordinance 2007-10; Cable Franchise - Cavalier Telephone. authorization for Town representation by attorney David Podolsky in the Cavalier Telephone franchise agreement.

Casey 6 and 7 Preliminary Plan

The preliminary plan for these properties was approved on October 18, 2007. The field behind Roberts Oxygen will be placed in a 20 month reservation for potential purchase by Park & Planning for future ballfields and park land.

LOS Condemnation

Park & Planning has filed a motion to reconsider. Attorney Bil Chen has filed a Town response.

Piedmont Crossing

A hearing on this proposed development is scheduled for Nov. 1, 2007. A number of deficiencies will be addressed by the Town, including wetlands recharge, landscaping along Ridge Road, well water impact and especially the density changes from the Preliminary Plan.

Public Comment Session about Restricted Turns at McCauley Street

The Mayor and Council are considering altering the current restrictions on turns at McCauley St. and Washington Grove Lane. The proposal is to prohibit right turns from McCauley St. onto W.G. Lane from 6:30 a.m. - 9:00 a.m. and from 4:00 p.m. - 6:30 p.m., Monday - Friday only, with the same prohibition for left turns from W.G. Lane onto McCauley Street. These turns would be permitted all other times of the day. You are invited to a public comment session on November 12, 2007 at 7:30 p.m. in the Council Room at McCathran Hall. This ordinance will grant Cavalier IPTV, LLC a non-exclusive franchise for the operation of a cable communications system within the corporate limits of the Town of Washington Grove. If you are going to erect a building or structure (including fences), make structural alterations to, or move any existing building or other structure, you must first obtain a building permit from the Washington Grove Planning Commission. The Town zoning ordinance governs setbacks, lot coverage and height. Applications are available at the Town Office at 301-926-2256. The permit fee is \$10.00, payable to the Town of Washington Grove. Interior renovations, which involve electrical, plumbing, or load-bearing changes, generally require a County permit. A shed requires a County permit as well. The Town must first sign off all applications for County-required building permits. The Historic Preservation Commission will review most permits as well.

New and long-time residents alike are reminded of the Town contract for the removal of leaves in bulk each autumn. US Lawns will make regular but unscheduled pickups of leaves raked or blown into windrows within six feet of any walkway or roadway, excluding Railroad Street, 2nd Ave., 3rd Ave., 4th Ave., 5th Ave., and Boundary Street. This service begins November 1 and ends January 1, 2008, or as soon thereafter as we agree that the work is complete. This is your opportunity to have leaves removed without the additional work and expense of bagging.

Weather frequently affects this process, as rain can restrict movement of large trucks on the avenues. Also, one or two spectacular fall weekends in November or early December usually see most of us raking at the same time. As the contractor will time pickups based on the availability of full truckloads for vacuuming, if you rake when most other people rake the windrows will probably disappear relatively quickly. Please place your windrows with an eye towards traffic visibility and flow,

and don't include brush or limbs that foul the vacuum. Happy raking! It's the rite of autumn, particularly in a town graced by so many beautiful deciduous trees.

Final Recyclable Yard Waste Pick Up

Per our contract with Montgomery County Sanitation and Recycling, November 29th will be the last date for collection of your big brown bags, bundles, or containers of recyclable yard waste for this year. This service will resume in early March. Town Maintenance will continue to collect your reasonably-sized brush piles.

Holiday Trash & Recycling Pickup Schedule

Recycling Questions & Answers...

Q: What kind of plastics can be recycled?

A: All clear and colored plastic bottles with necks (regardless of the resin number on the bottom).

Q: Can other plastics with resin codes be recycled?

A: No. Unfortunately, no other plastics can be recycled. Ex: yogurt containers, margarine tubs, pint-sized baskets for fruit, beverage cups, salad bar containers, flower pots. These are all no-no's.

Q: What about the lids and/or caps?

A: Lids/caps are not recyclable. Please put lids/caps into the trash.

Q: Can't we just recycle anything with a resin code?

A: No. Resin codes (numbers on the bottom) no longer determine whether an item is recyclable or not. If the plastic container has a narrow neck (like a bottle), then you may recycle it. Anything else should be put into the trash.

Q: What about batteries?

A: Dry cell and alkaline batteries used in flashlights, toys, and appliances are no longer considered to be hazardous waste. Manufacturers responded to environmental concerns, and now produce dry cell and alkaline batteries that are virtually free of mercury. Therefore, these batteries may be disposed of in your household trash.

Q: What about button batteries, nickel-cadmium (rechargeable) batteries, uninterruptible power supplies and lead acid (car) batteries?

A: These batteries continue to contain metals which are valuable, or which must be disposed of properly. Take these batteries to rechargeable battery bins in the Shady Grove Transfer Station's recycling drop-off area. Clerk's Corner
