Town Council Reports July 2014

HISTORIC PRESERVATION COMMISSION – Georgette Cole

Permit review:

501 Brown Street, Winkler-Stopak: submitted completed permit application with boundary survey, drawings and elevations with photographs. House is not a contributing structure. The HPC discussed and approved the plans. Mimi Styles will write up the reviews and get it to Kathy by July 23.

301 Washington Grove Lane, Partington-Gillis: submitted plans for internal remodel. Planning Commission advised HPC review since several windows are involved which will change the appearance of the house. No permit is required by Washington Grove for this work.

201 Maple Road, Jim Snyder: building permit for enclosure of a garage. The HPC reviewed the material carefully and conclude the submitted material was not sufficient for a review of the proposed work and final structure. It would be helpful to have the plans Mr. Snyder will submit to the County.

346 Ridge Road, new resident. There was an email from Charlie Challstrom indicating a permit had been approved, but no permit form/plans were available for HPC review.

506 Brown Street, Wongkachonkitti: Solar panels. These will not be visible from a public way and thus do not require an HPC review.

402 Grove/207 Grove-moving shed. The HPC declined to review this.

SHADY GROVE CROSSING – Georgette Cole

The Shady Grove Crossing development is almost finished. I have contacted the site manager to clean up some pending issues and expect to have more information next month.

WASHINGTON GROVE MEADOW CONSERVATION PARK - Georgette Cole

Mayor McCathran and Georgette Cole met with Park Manager, Mike Jones, on July 24. The recent inspection of the meadow for Non-Native Invasive plants (NNIs) was discussed. The results are very encouraging. We then reviewed the Meadow Operations and Use Plan. It shows an oval walking path with a path crossing the oval from the front entrance to the lower field entrance. The Parks Department has limited personnel and plans to mow this path twice a month during the grass growing season. The Mayor said that residents had expressed a strong preference for more frequent mowing due to the tick hazard when the grass was higher. She suggested that Town Maintenance might be able to help with the process. We agreed this was a workable solution. Mike expressed concern over continued resident mowing of the Ridge Road edge of the field. A resident in Shady Grove Crossing has started a vegetable garden on the meadow next to his property. Mike will wait until fall then remind residents these activities must not continue next year.

FORESTRY & BEAUTIFICATION – Audrey Maskery

The deep drainage ditch by the lake in the West Woods has started to be filled with rocks and concrete. Once in place, the filling will be secured with a concrete mix; hard work in the summer heat by Steve Wertz and crew. Hopefully the filling will help to slow the velocity of runoff from Washington Grove Lane.

407 Acorn – no longer excavating road. Owner will construct a concrete curb to redirect water away from home. Section of curb located on town/public property approved.

RR Bridge on schedule. Curved beam installation delayed due to cable wire location preventing crane access. They have been installed.

WSSC – Waste pipe along Maple Ave to be cleaned and have sleeve installed using man holes to minimize digging
