### 988 Lifeline

Please also consider the **9-8-8 Program** to enhance your personal safety and wellbeing. The 9-8-8 Suicide and Crisis Lifeline is a United States-based suicide prevention network of over 200+ crisis centers that provides 24/7 service via a toll-free hotline with the number 9-8-8. It is available to anyone in suicidal crisis or emotional distress. It's part of a larger initiative to build out a behavioral health infrastructure for people in distress to have someone to call, someone to come and somewhere to go. "9-8-8" calls, texts, and chat are answered by trained, compassionate behavioral health professionals who know community mental health and substance use resources. They will listen, offer support and work together with the caller to develop a plan for safety and recovery.

### **Why are our oak trees dying?**

We've been asked about the current sudden decline of our beautiful oak trees. This is NOT due to any specific disease or pest. It is largely due to old age exacerbated by pollution and changing weather patterns which have stressed the trees. Remember that the Camp Meeting Association bought the land for Washington Grove in 1873 because it included "old woods, reputed to be virgin forest" (P. Edwards A History of Washington Grove). The oaks were already at least 50 years old at that time, possibly older.

Now they are 200 years and upward, which is an advanced age for trees in an increasingly urbanized environment. The Town is doing its best to preserve the remaining trees, especially by selective pruning which removes dangerous limbs and also thins the crowns to reduce wind-shear in stormy weather. ## Bollard Lights

We have gotten permission from the Maryland Historical Trust and the TWG Town Council to purchase and install two more low voltage bollard lights around McCathran hall. They should be installed in the next week or so.

## Streetlights

Due to advocacy on the part of some Maryland municipalities including the Town of Washington Grove, the Maryland Public Service Commission (MD-PSC) rejected Pepco's new streetlight tariff and directed them to meet with Maryland municipalities concerning options on streetlight ownership.

Pepco announced a series of four meetings on September 14, 21, and 28 and October 6 - each three hours long - to discuss "The Pepco and Municipality Streetlight Purchase Process".

Town Councilor Dave Cosson and the Streetlight Committee chair Virginia Quesada have attended the first three meetings and will be attending the last. Additionally, we will be attending a fourth meeting in Baltimore on October 12<sup>th</sup> where Pepco and the municipalities will be discussing their progress on the process of streetlight ownership to the MD PSC.

This is a surprisingly complex issue and though it is far from a resolution at this point, in general, these discussions have been positive in terms of trying to forge some sort of reasonable compromise between the different entities.

The Lighting Committee was formed to deal with our municipal streetlights.

## **Dark Skies**

There seems to be continued interest in dark sky compliance and we would like to suggest that we follow the lead of other communities who have successfully formed a separate Dark Sky Compliance Committee. We would encourage the formation of a new committee to head this up. TWG Lighting Committee does need to focus on the complex issues now surrounding municipal streetlights but we do support dark sky compliance and we would like to repeat our recommendations from earlier this year.

### **Why should our residential lighting try to be dark sky-compliant?**

There isn't much we can do about glare from our streetlights until we purchase them from Pepco, but we can make important, incremental changes to residential lighting to improve our health and that of the wildlife we depend on. At the same time, we may reduce energy consumption. By directing light down to walkways, paths and driveways we protect the dark night sky and the myriad creatures who need it for finding food, navigating, mating and migration. Our own circadian rhythm would not be disrupted by glare, giving a better night's sleep and associated health benefits. Remember, dark skies do not mean darker walkways! Directing light down instead of up can help rather than hinder safety.

International Dark Skies (IDS) estimates that 30% of light is "wasted" and a whopping 15 million tons of CO<sub>2</sub> is emitted to power residential lighting!

### **This is what you can do around your property:**

- 1) Assess your external lights. Are they all necessary? Does the light fall only when and where it is needed?
- 2) LED bulbs can be more energy efficient than incandescent bulbs. For warmer light use LED bulbs that are rated 3000 Kelvin or less.
- 3) Improve your lights by replacing fixtures with those that are [dark sky-compliant](#).

*Dark Sky – denoting or located in a place where the darkness of the night sky is relatively free of interference of artificial light.*

If you're handy, some lights can be retrofitted with a simple shield to prevent light traveling up into the sky.

### Induction Cooking: Cooktops, Ranges, and Portable Units

If it's time to replace your cooktop or range, it's a good idea to consider induction models. Induction models first appeared in stores in the 1980's and are now the preferred option for many people because of their energy efficiency. They resemble smooth glass-top traditional electric models in appearance but there's a big difference in how they work. Induction cooking does not radiate heat on its own; it creates an electromagnetic field that interacts with compatible cookware. It causes the cookware itself to heat up, which leads to several advantages.

**Advantages.** The biggest advantage is the gain in energy efficiency. With induction cooking, as much as 90% of the energy consumed goes into cooking the food. Sources vary widely on the efficiency advantage of induction over conventional electricity; the government's Energy Star program claims the technology is 5-to-10% more efficient, while others report it as much higher. Compared with natural gas or propane cooking, induction may be as high as three times more energy efficient, because no heat is lost to the area around the pot or pan as it is with an open flame.

Induction cooking is fast; you can boil water in less than half the time it takes with other forms of cooking, and it's very responsive to temperature adjustment. Because the cooktop itself stays relatively cool, induction tops reduce the risk of burns. The cooktop cleans up easily because spills cannot bake on and cause charring. And, compared with natural gas or propane, induction cooking is much better for indoor air quality.

**Disadvantages.** Induction cooking works only with ferrous cookware, which includes cast iron and stainless steel. Aluminum or copper pots and pans without an iron core won't work unless you place an iron or steel plate between the cookware and the burner. If a magnet sticks to the cookware, the cookware will work with induction. Induction doesn't work well with small-bottomed cookware, such as a wok; it's best to use flat-bottomed cookware to ensure even heating. Fan noise (a fan is built in to keep the electronics cool) and an occasional ringing noise (metal pot lids can "sing") annoy some people. Finally, there are concerns that induction could interfere with certain models of cardiac pacemakers.

**Features.** Cooktops vary in the number of burners and the number of power levels offered for temperature control. Some have a boil function for going to maximum power fast. Other features are a bridge setting to heat a large skillet; a warming ring; and even cooktops on which you can place the pot anywhere...the unit recognizes the placement of the pot and reacts accordingly. Magic! Ovens in ranges are conventional electric, conventional electric with an optional convection setting, or even double ovens.

**Costs.** A full cooktop or range with induction cooking can cost from about \$1,000 to \$6,000, depending on the features included. If you are replacing a conventional electric stove, you likely have the electrical circuitry in place, and an induction unit will go in place without any added expenses for an electrician. But, if you are converting from natural gas or propane and don't have the proper circuitry for an electric range, you could have a significant additional electrical cost to install the wiring required for an induction range. Be sure to investigate that possibility before investing in an induction cooktop or range.

**Household Electrification Incentives.** Good news! The Inflation Reduction Act of 2022, which was signed into law on August 16, 2022, authorizes many valuable discounts, tax credits, and rebates. Once the incentive programs are up and running through the states, you may qualify for up to \$840 toward the purchase of an induction range or cooktop and up to an additional \$500 to defray your outlay for converting from propane or natural gas to electric, and you may be able to get a tax credit of up to \$4,000 if you are required to upgrade your home electrical panel in order to accommodate an electric appliance. **Portable Units.** Portable induction cooktops offer another choice in induction cooking. You can buy single or double burner portable units that typically work with a 120-volt, 15-amp circuit, that is, any standard outlet. They usually cost between \$50 and \$250. Higher-end professional models can accept more weight; lower-end models have reduced features, such as fewer power levels.

### **Notes on Induction Cooking from Your Neighbors**

**Sung Chang:** Samantha and I were remodeling our circa 1940's kitchen. We weren't happy with the existing conventional (radiant heat) electric range, and it was impractical to consider natural gas or propane. We looked into induction and are glad we did. We needed to upgrade the electric anyway, so that cost was not an issue. We love how easy it is to clean compared to the old unit.

**Bruce Daggy:** Our kitchen has a propane cooktop. Anne and I didn't like the impact that has on indoor air quality, but we weren't sure about spending thousands of dollars for the unit and rewiring when we had never tried induction. So, for about \$120 we bought a portable induction

cooktop. We typically need only one burner at a time; induction has reduced our use of the propane cooktop by more than 90%. The portable unit is much better for air quality and is a breeze to clean up. We use it every day.

**Kitty Seiferlein:** Mark and I are enthusiastic users of this technology. We learned about the technology years ago at the annual international energy efficient home competition on the national mall where energy efficiency was a top feature of the model homes. Every single model home had an induction stove; a must to be competitive. So, we bought our first induction stove then, and when it finally wore out, bought our second. In addition, some time ago, Mark bought a one-burner portable version for emergencies. We've used the portable successfully a couple of times.

### **News from the Garden**

Recently you may have noticed some unusual activity inside the tennis court fence. In mid-June, the Town Council approved an 18-month pilot for a community garden. The Historic Preservation Committee favorably reviewed the garden proposal (as reported in the August 2022 Town Bulletin), and now the Planning Commission has done so as well. The volunteers who formed the "Edible Garden Group" (EGG) are sponsored by the Grove's Sustainability Committee.

There are many reasons to make an edible garden today when food supplies are threatened globally. We want to be part of a movement that restores our historic ability to grow produce locally. We want to reawaken our knowledge and share the bounty with those that are food insecure. We want to build resilience for this community, now and in the future.

The tennis court location is an ideal starter space. The fence keeps out deer, the garden receives over six hours per day of sunlight, water is available nearby, we have use of part of the shed to store tools, and the centrally located site is easily accessed.

The plan is to grow the soil this year with cover crops, mulch, etc. using no-dig methods to prepare it for planting in the spring. However, one small section of the long bed was tilled, amended with aged horse manure and fertilizers, and planted with sweet potatoes, which will be given to local food pantries if they grow well. A soil test revealed the soil to be deficient in phosphorus and potassium and these deficiencies were corrected. Pathways of woodchip over cardboard have been laid in between the beds. A summer cover crop of buckwheat has been planted in the long bed. This is an effective natural method of keeping weeds down and feeding the soil biomass and bio-available phosphorus. After the buckwheat is cut down in the fall, we

expect to plant garlic in this bed. The short beds will be planted with a fall cover crop, crimson clover.

## Deer Management

We are continuing the Town of Washington Grove's Deer Management Program in the East and West Woods with our volunteer Bow Hunter Fire Fighters of Maryland (BHFFMD) this Fall-Winter deer hunting season as regulated by the Maryland DNR. The season began on Friday, September 9, 2022 and will run until Tuesday, January 31, 2022. The BHFFMD are skilled archers and certified EMTs. ***Safety First! This is the focus for BHFFMD and the Woods Committee!*** Bow hunting will occur only at sunrise and sunset, and the Woods Preserves will remain open during archery season. The Woods Committee has posted 'Deer Hunting by Permit of TWG' signs at the East and West Woods trail entrances. ## Stormwater Mitigation

## **Other Notices**

### **Bulk Trash Collection**

The Town has scheduled a bulk trash collection for **Saturday, October 15, 2022**. Materials may include furniture, appliances (nothing with freon



like air conditioning units), rugs, large toys, small auto parts, etc. Material may NOT include construction by-products from your renovation projects, large automotive parts, or tires. Items should not contain gasoline or motor oil. Please keep your metal separate from the rest of your trash.

## **Bulk Leaf Collection Begins October 31, 2022**

New and long-time residents alike are reminded of the Town contract for bulk leaf removal each autumn. The contractor, Green Earth, Inc., will make regular but unscheduled pickups of leaves raked or blown into windrows within six feet of any roadway or walkway, excluding Railroad Street, 2nd Ave., 3rd Ave., 4th Ave., 5th Ave., and Boundary Street. This service begins October 31, 2022 and ends January 5, 2023, or as soon thereafter as we agree the work is complete. This is the only time to have leaves removed without bagging for recycling.

The contractor will time pickups based on the availability of full truckloads for vacuuming. One or two spectacular fall weekends in November or early December usually have most of us raking at the same time. If you rake when most others are raking, the windrows will probably disappear relatively quickly.

Please place your windrows within six feet of the road or walkway (keeping in mind vehicle and pedestrian traffic).

Green Earth will collect leaves by working from one end of the Town to the other, typically starting with Ridge Road working their way across the community, first removing piles along roads for safety reasons. After making one pass along roads, they will focus on walkways. If roads become obstructed before walkways are completed, roads will be cleared until they are safe. Then collection will resume along walkways. Weather may affect this process. Rain can restrict movement of large trucks on the avenues and accumulated snow, or freezing rain may make piles too heavy to vacuum. **The contractor will not remove leaf piles that contain branches, brush, pruned limbs, and cut ornamental grasses. Please do not add these to leaf piles. They foul the vacuum and Green Earth will not collect piles containing this material.**
