Wells and Pumps

Although the site selected by the Washington Grove Camp Meeting Association possessed natural springs that were said to sparkle with "life-invigorating properties," one of the first improvements to the landscape was to dig several wells and install pumps to draw the water ("Washington Grove, A Delightful Resort – the Grounds and Cottages – Opening of the Camp," Washington Post, August 5, 1883). The wells provided an accessible source of water for drinking and other daily needs. A newspaper account reported, "The pumps have been repaired and one or two new

wells dug, guaranteeing plenty of the best water ever drawn from the ground." ("The Camp Meeting Season," Evening Star, August 11, 1881). The 1886 Lang plan identified the location of at least seven wells within or near the Tent Department. As residential development expanded to other parts of the Grove, additional wells were added.

By the late nineteenth century, the list included the Allen (also known as Broadway) well, the Jackson Park well, the depot well, the Hotel Park well, the well in the superintendent's yard, the Dorsey well, the Wide well, the Platt well, the Benson well, and the Sixth Avenue well. In 1897, a water tank on a raised stand was erected in the hotel yard. Water from the hotel well was pumped into the tank and routed to a boiler in the kitchen, providing guests with hot water.

In the off-season, the pumps were removed from the wells and well covers were put in place. Washington Grove's wells were frequently inspected, and the water tested to ensure a clean supply. Over time, repairs were required, such as relining the wells with terra cotta pipe, partially filling the wells to prevent excess standing water, or redrilling. The Washington Suburban Sanitary Commission brought a modern water and sewer system to Washington Grove in 1927, although many residents were slow to install indoor plumbing and connections. By 1938, however, all the wells were filled, and most of the pumps were pulled.

Today, there is still evidence of Washington Grove's well water system, which supplied water to residents for over fifty years. Examples include the well pumps in the yard of 127 Maple Avenue and under the carport of the house at 201 Grove Avenue. Near the back of the house at 117 Grove Avenue stands a frame well house with a hipped roof, exposed rafters, and wood siding. There is also a well house located at 12 the Circle, at the eastern end of the lot, near the Circle.

The Lighting Committee is working with other Maryland municipalities to allow the option of municipal streetlight ownership. Our streetlights are currently owned by Pepco. If the Town owned its streetlights, we would not be in repeated danger of Pepco trying to pass a tariff that would allow them to replace all our streetlights with some ugly options and then charge us a lot for them in perpetuity. If we owned our own streetlights, it would allow us to maintain the savings that we have gotten from two conversions of our streetlights from an annual cost of approximately \$20,000 to \$5,000. It will give us the opportunity to control the aesthetics and functionality of our streetlights and walkways. Additionally, if we owned our lights, we would be eligible for grants like those from the Maryland Energy Administration's Streetlight and Outdoor Lighting Efficiency (SOLE) FY 2024 grant program.

Sustainability Investments at 404 Brown Street

Oscar Ramos and Sara Parent-Ramos moved from California into 404 Brown Street in 2020 and soon took on a number of investments to make their new home more energy efficient.

The first step was to have a professional energy audit done to find out what changes would have the best payoff.

The audit indicated that insulating the basement rim joist and adding insulation to the attic had the best payback. Oscar and Sara invested in the insulation, followed by other sustainability improvements, including 20 solar panels on the roof (two on the front of the house and 18 on the back); a two-stage heat pump to take the load off the oil furnace; and new energy efficient washer and dryer. The oil furnace is now a back-up system instead of the primary heat source and is not in use much. What the heat pump doesn't supply, the home's wood stove usually does.

Oscar compared this year's November-December month's electric usage vs. that period a year ago and found that their bill is down as much as 30%. This is during the period of the year where the solar panels receive the least amount of sun exposure. During the summer, the panels generated 100% of the house's electrical use. Oscar and Sara are highly satisfied with their decision to go solar, and they are looking forward to the 30% federal tax credit on the purchase cost of the panels. Everyone loves a lower electric bill!

Updated Electric Vehicle (EV) Tax Credits in 2024

Federal tax credits for new EVs have changed for purchases made in 2024.

Now buyers can choose to transfer their new or used EV or plug-in hybrid vehicle tax credit to a registered car dealer in exchange for an equivalent reduction in the purchase price of the vehicle. This is a true advantage for consumers. The dealer must submit a time-of-sale report to the IRS with buyer and vehicle information. Be sure to get a copy of that report when you make the purchase. See the one-page **IRS publication 5900** for more information.

New requirements of manufacturers mean fewer vehicles being purchased in 2024 qualify for the tax credits. Below is the current list, but more models may qualify eventually, so please refer to **this FuelEconomy.gov page** for updates.

To qualify for a tax credit on a new vehicle, the buyer's adjusted gross income may not exceed:

- Married filing jointly or surviving spouse: \$300,000
- Head of household: \$225,000
- All other taxpayers: \$150,000

With fewer new models qualifying for tax credits in 2024, buying a used vehicle might be a smart choice. Federal tax credits for 106 pre-owned models are listed at <u>this FuelEconomy.gov page</u>.

Tax Credits for New EVs

The following vehicles are eligible for tax credits under the Inflation Reduction Act based on the latest guidance from the Treasury Department. The credits are for new vehicles placed in service during 2024.

To qualify for a tax credit, the used EV must be purchased on or after January 1, 2023. The credit can equal 30% of the sale price up to a maximum of \$4000. The vehicle must be purchased from a dealer, have a sale price of \$25,000 or less, and have a model year at least two years prior to the current calendar year. The buyer's adjusted gross income may not exceed:

- Married filing jointly or surviving spouse: \$150,000
- Head of household: \$112,500
- All other taxpayers: \$75,000

Maryland offers an excise tax credit up to \$3000 for an EV or fuel-cell vehicle whose maximum cost is \$50,000. For more information, see <u>the MD DOT Titling - Excise Tax Credit for Plug-in</u> <u>Electric Vehicles page.</u>

With the Federal \$7500 tax credit, Maryland state tax credit \$3000, and <u>Washington Grove's</u> **\$1500 incentive pilot program**, you could save as much as \$12,000 on your EV.

In addition to EV tax credits, there is a federal tax credit of 30% of the cost, up to a maximum of \$1000, for charging equipment installed at your home. File <u>form 8911</u> with your taxes. Currently, Maryland's rebate program funds for charging equipment may be exhausted; <u>watch this site for news</u>.
