# **Town Council Enacts Ordinance Adopting the Town Budget and Tax Rates for FY25**

Maryland law requires municipal tax rates and budgets to be adopted by ordinance. On May 21<sup>st</sup>, the Town Council affirmed the action taken by the May 11<sup>th</sup> Town Meeting and enacted Ordinance 2024-01 adopting the budget and tax rates.

## **Town Meeting News**

#### **Town Election Results**

Annual Town elections were held Saturday, May 12<sup>th</sup>, in advance of the Town Meeting. John Compton was elected to a one-year term as Mayor. Kriss Grisham and Barbara Raimondo were elected to Town Council for three-year terms. As always, deep gratitude to those willing to give of their time, energy, and talents in serving the Town in these capacities. Thanks as well to all who participated in the voting.

#### **Annual Town Meeting**

The 88<sup>th</sup> Annual Town Meeting was held virtually by Zoom Saturday, May 11, 2024 and was attended by approximately 85 resident voters. Mayor Compton delivered his "State of the Town" report, Chair Georgette Cole presented a report from the Planning Commission, and Chair Bob Booher gave the Historic Preservation Commission report and "2024 Preservation Award" to Phil and Lynn Mento at 102 Center Street.

The meeting also heard a presentation from Woods Committee Co-chair Patrice Klein on stormwater management issues in the West Woods and the current Stormwater Infrastructure Management RFP, a project to better control stormwater run-off in residential areas west of Grove Avenue and into the West Woods by renovating and upgrading culvert and floodwater infrastructure.

A report on "Sustainability" from Paul Patrone reviewed efforts to reduce the Town's carbon footprint, summarized the initial year of the Renewable Energy Conversion Incentive Pilot Program, and recommending renewal of the program for FY25.

The "Future of the Commercial Corner" was addressed by Town Councilor and Planning Commissioner Peter Nagrod, in which he reviewed the vision for the property in the Town's 2022 Comprehensive Plan and recent cooperative efforts with the property owner, including removal of the dumpster, concept drawings for renovation of the buildings, and a proposal from Gaithersburg to construct a bikeway from Old Town and along the property to Brown Street.

### **FY25** Budget and Tax Rates Approved

The Budget and Tax Rates recommended by the Town Council were adopted by residents at the Town Meeting. The Real Property Tax rate for FY25 will be \$0.2326/\$100 assessed valuation, which is the constant-yield rate which is expected to generate the same amount of revenue as generated during FY24. The Dwelling Unit Tax to recover the cost of trash and recycling collection from property owners will be \$173 per dwelling for FY25. This amount includes a credit of \$39 because costs in FY24 were lower than anticipated.

## Have you seen the entry for your home under Washington Grove House Histories on the Town website?

Here you will find information about each home in Town. While some entries are sparse, others are more expansive and provide interesting information not only about the home itself, but also tidbits about the town's history. In cases where the builder was known, or if an owner had ascribed a name to the home, that information may be included as well.

As an example – take a look at the entry for 122 Grove Avenue, where you may recognize the names of two Town parks reflected in the listing of early owners of the property.

Wachter, by 1946 Florence B. Hall (liber 1844 folio 512) George C. & E. K. Frantz, 14 October 1964 (liber 3280 folio 193) Nils E. & Margaret M. Erickson, 6 July 1971 (liber 4090 folio 383)

**Remarks** » House appears on 1886 plat. The southern portion of lot 25 was used as a cross-through from 1905 into the early 1960s. Herbert L. Davis was referee and Auditor-in-Charge of the old Supreme Court of the District of Columbia from 1915 to 1931. He was later an instructor at the National University Law School. Mrs. Alfred Wood protested use of adjacent lot (now 118 Grove Avenue) as tennis court and baseball field (1896-1904).

**Sources** » Edwards, p. 91, 207-208; 1886 plat of Grove Avenue; Record of Leases, 1883-1906; tax records; Assessment records; 1946 tax list; Register of Stock Certificates; Shantz p. 75; Association minutes 18 May 1896, 24 June 1896, 1 June 1897 and 12 March 1904.

Note that in most cases, the listing of owners has not been updated since before the turn of the century.

The deadline to submit a building permit application for approval by the Planning Commission and review by the Historic Preservation Commission is **the 2<sup>nd</sup> Wednesday of the month** prior to the PC meeting at which the permit will be reviewed (this will be in the following month). This timing ensures the HPC will be able to complete a formal review before the PC meeting as this review is required for the PC to approve the permit in a timely fashion. If you are considering any renovation or building project at your house, be sure to get a copy of the procedures to apply for a Town Building Permit which will help you through the Town's process.

#### **Ioin Zoom Meeting**

On May 24th 14 volunteers met in the Conservation Park for a work party supervised by Silvia Nuñez, a Natural Resources Specialist with the Montgomery Parks Weed Warrior program. We removed Canada thistle, mile-a-minute, and wineberry from an area of the meadow near the intersection of Ridge Road and Oak St. If you walk by this location, you may notice that we did

not need to bag and remove these non-native invasives. We uprooted the plants before they formed seeds, so it's fine to let them decompose in place.

Over time this approach will deplete the seed bank in the soil while giving native species more elbow room to grow. Thanks to residents Anne Spector, Anne Vincent, Audrey Maskery, Betsy Klinger, Ernie Kawasaki, Janet Lottero, Jay Everhart, Joan Mahaffey, Jolie McCathran, Kriss Grisham, Margo Cavenaugh, and Patty Klein, plus Rockville native Diana Gilpatrick, for making this event a success.

We are coordinating with Parks to schedule the next event on a weekday in the late afternoon or on a Saturday so that students wanting SSL hours plus 9-to-5ers can join in. No experience necessary -- in a few minutes you can learn what to do. Parks also offers Weed Warrior training and certification so you could work independently on your own schedule. ## **Town EV Charging Stations at One Year**

On June 10, 2023, four new electric vehicle (EV) charging stations opened for business at Center Street and Chestnut Road, directly across from McCathran Hall. The stations were installed by Pepco at no cost to the town.

In the first few weeks, it was rare to see a vehicle being charged, but usage picked up once drivers began to find them, and the stations appeared on EV station maps. In the first six months of operation, the four stations recorded about 500 kWh of power sold; in the following six months, the usage rate picked up and more than five times as much power was sold. Now it's common to see the chargers in use. We are looking forward to the first time we see all four stations busy at once!

#### To use a charging station:

- Download the free "Shell Recharge" app from the Apple store or the Google Play store and sign up for an account.
- At the charging station, connect the cable to your EV and open the app.
- Scan the OR code or enter the Station ID.
- Select "Start Charging".

## **Town Municipal Account Now on Community Solar Electricity**

Washington Grove's municipal electricity service, which powers McCathran Hall, the maintenance building, and Maple Lake, has been switched to a community solar provider.

The Town has subscribed to acquire its electricity from the Central Baptist Church of Rockville, MD, which has installed a 148.42-kW solar roof system. Other subscribers to the church's solar power include the Jewish Council for the Aging and Bradley Hills Presbyterian Church.

A direct loan from Montgomery County's Green Bank to Skyview Ventures Company and a community solar roof lease agreement with Central Baptist Church made this project possible without any upfront capital investment by the church.

Our town's electrical account is small, but this is a good step toward shifting Washington Grove away from the use of fossil fuels wherever possible.

We encourage residents to shift their home accounts to community solar as well. To find out at no charge how it works and where slots are currently available to join a solar electric farm, contact Kevin Cheung, Utility Advisor, at <a href="mailto:Kevin@utilityadvisor.org">Kevin@utilityadvisor.org</a> or call 443-888-2123. Community solar offers a guaranteed savings of up to 10%, and, households with an annual income at or below \$78,768 may qualify for a 25% discount.

We are always looking for new members to help protect our East and West Woods Forest Preserves. Please consider attending a Woods Committee meeting to learn about our projects and join us!

In May, Pat Klein and Dave Cosson represented the Woods Committee during Stormwater Mitigation "Request for Proposals" (RFP) site visits with Mayor Compton and potential contract bidders of public roads and walkways designated for storm water infrastructure repair and improvement. RFP bid submissions are due in early July for Town Council review.

In collaboration with MoCo Parks and the *ad hoc* Meadows Working Group, several members of the Woods Committee (Joan Mahaffey, Pat Klein, Joli McCathran) participated in a Weed Warrior Workday event on Mary 24th to physically remove non-native invasive (NNI) mile-a-minute, Canada thistle, and wineberry plants from the Conservation Meadow along the Ridge Road boundary.

IPC, our NNI plant control contractor is scheduled to perform targeted herbicide treatments for wisteria, mile-a-minute, Japanese knotweed, and other non-native plants in June. A Grove Alert will be distributed, and signs posted in active work areas once the dates are scheduled.

A reminder that we have installed trail marker signs in the East and West Woods to help everyone stay on the designated walking trails and protect our understory native plant vegetation. Please do not create or cut any new trails in the East and West Woods. We ask that you contact the Woods Committee co-chairs to discuss before taking such actions. Please do not walk or bike on the walking trails that are too wet and muddy to avoid rutting and soil erosion and be careful on the walking trails in the Woods on windy days.

Several trees have fallen in the East Woods across the Challstrom and Silver Dollar trails. Woods Committee Co-chairs, Joan Mahaffey and Pat Klein, are working to remove the downed trees blocking the walking trails. Please do NOT try to remove or cut back fallen trees on your own without first contacting the Mayor, Town Office, or Woods Committee co-chairs. Your safety comes first!

Also, please contact the Town Office or Woods Committee co-chairs if you see suspicious behavior in the East or West Woods. We want everyone to enjoy the woods and learn about nature in a safe, non-destructive way.
