

Minutes of the Town Council Tuesday, July 30, 2024, 7:30 p.m. Approved November 11, 2024

**Call to Order:** Mayor John Compton called the meeting of the Town Council to order at 7:35 p.m. With Councilors Kriss Grisham, Peter Nagrod, Eva Patrone, Robert Gilmore, Barbara Raimondo were present. Some residents and guests were also in attendance. Councilor Mary Warfield joined the meeting at 7:51 p.m.

**Approval of Agenda:** Barbara Raimondo moved to approve the agenda. Peter Nagrod seconded the motion seconded the motion.

Action: Vote: 5-0, Agenda approved.
